DILG R1 passes QMS Audit, now ISO certified



ISO certification for Quality Management System (QMS) was conferred to DILG Region 1 after having passed the stage 2 audit conducted by Certification International Philippines Inc. (CIP Inc.) on December 13-14 and 18, 2018.

The award was received by then-ARD Victoria H. Ramos who served as the Regional Quality Management Representative (QMR), and was presented to the personnel of the region by Regional Director James F. Fadrilan and all the provincial directors and division chiefs in a ceremony held at Monarch Hotel, Calasiao, Pangasinan on March 22, 2019.

Prior to the stage 2 audit, a readiness assessment also known as Pre-Certification Audit was conducted by DILG Central Office Internal Quality Audit Team which determined the preparedness for external audit of the region as to the compliance of the legal, organizational and ISO requirements.

With the collective efforts of the QMS core team and process owners and guidance of consultants, the office was able to document and enroll the streamlined core and support quality processes thus making the region confident in getting the certification.

The establishment, implementation and certification of ISO 9001:2015 QMS is in compliance with EO 605 directing all government offices to carry out QMS that will institutionalize structures, mechanisms, and standards in government to ensure quality in systems and processes in government operations. It is also a condition set to be eligible for the Performance-Based Bonus (PBB) of government offices. (IO III Alethea A. Cedo)

Aimed at gathering feedbacks and updates in the implementation of LGUs to DILG PPAs through the City Municipal Local Government Operations Officers (C/MLGOOs), the Department of the Interior and Local Government Region 1 (DILG R1) conducted a C/MLGOO Conference: Development Dialogue with the Undersecretary for Local Government (USLG) during the DILG R1 Fieldsmen's Conference cum Health and Wellness Program on March 22-23, 2019 at The Monarch Hotel, Calasiao, Pangasinan.

USLG Marivel C. Sacendoncillo together with former Region 12 Director Reymund Bungubung, Regional Director James F. Fadrilan, and Assistant Regional Director Victoria H. Ramos with the field officers assigned to different LGUs in the region engaged in a Development Forum/Talk.

USLG Sacendoncillo presiding over the conference, started with her message about the Department's Thrusts and Mandate and emphasized the role of the C/MLGOOs who are closer to the ground. In her message she further emphasized the principle of subsidiarity, wherein we must do only the things that we can do and leave the things that we can't do to those who can do it.

She also highlighted the role of the department in championing excellence in local governance and stressed out that everyone is responsible for the political development of the LGUs.

"The DILG being the lead for the participatory governance must be responsible for developing the good relationship of the government with the constituents," she added.

The activity aimed to; orient and train the regional focal persons and field officers on the CSIS Mainstreaming for 2019 in 77 municipalities; discuss implementation-related topics and identify plans of actions towards achievement of project accomplishments; conduct demonstration of the enhanced CSIS portal; and establish data capture point for CPAP (Citizen Driven Priority Action Plan).

Ilocos Norte SK Federation gets briefing on SK Budgeting Process



The Sangguniang Kabataan (SK) Federation in Ilocos Norte headed by Hon. Rafael Salvador Medina in coordination with the DILG- IN headed by Provincial Director Reggie R. Colisao, CESO V together with the Ilocos Norte COA Representative Bradley Policarpio, Provincial Budget Officer Evangeline Tabulog and other concerned officers from the local government units discussed the DBM-DILG-NYC Joint Memorandum Circular No. 1, s. 2019 dated January 23, 2019 re: "Guidelines on the Appropriation, Release, Planning and Budgeting Process for the SK Funds" on February 7, 2019 at the Provincial Auditorium, Provincial Capitol, Laoag City, Ilocos Norte.

PD Colisao presented the Budget Process, from Budget Preparation to Budget Accountability including the sanctions on non-compliant SK Officials. She emphasized that there is a need to finalize first the Provincial Youth Development Plan (PYDP) in order to come up with the Comprehensive Barangay Youth Development Plan (CBYDP). The PYDP will serve as basis for the programs, projects and activities (PPAs) to be implemented at the barangay level. Provincial Budget Officer Evangeline Tabulog also supplemented the discussion and shared the actual processes done in the Province.

An open forum followed after the presentation. Ilocos Norte Youth Development Officer (INYDO) Weenter P. Ventura raised the issue concerning the formulation of the PYDP and made some clarifications as to what PPAs to include. PD Colisao said that all the nine (9) priority areas under the said JMC should be given PPAs but their plans will differ in the allocation depending on their needs and priorities. Other issues include: opening of SK bank accounts; allowance for SK Kagawads; and SK Mandatory Training (SKMT) schedule. The Mandatory Training for the SK Officials is to be conducted after all the barangays are done with the Special Elections. This shall be coordinated with the Local Youth Development Officers and the DILG Field Officers. She also said that a separate guideline will be issued by COA concerning the release and use of SK Funds, and the opening of accounts among others.

DILG inaugurates local bridge Barangay Anset assured of easier access




n February 8, 2019, the inauguration of Angset Bridge was held at Brgy. Angset, Carasi, Ilocos Norte. DILG-Ilocos Norte Provincial Director Reggie R. Colisao, CESO V was the guest of honor and speaker. Rev. Fr. Tranquilino Santos of the St. Joseph The Worker Parish of Carasi officiated its blessing. witnessed by no less than the Municipal Mayor, Hon. Rene V. Gaspar, together with municipal officials and staff, the Barangay Officials, members of the PNP, MLGOO and DILG-Ilocos Norte Special Projects Unit personnel.

The local bridge costs PhP 7,511,233.00 and it provides easier access to 33 households of Brgy. Angset. construction of the bridge was proposed by the municipal government as priority project due to the inaccessibility of the barangay during rainy season. The old Angset Bridge, which was constructed in the 90's was low-lying. It becomes flooded during heavy rainfall that the barangay becomes isolated. Relief goods and basic services could not be delivered in time to victims of calamities.

"We cannot afford to build this bridge, that's why we are very thankful to the National Government, especially the DILG, for providing funds for development projects to LGUs. It is a dream come true, not just to the residents of Brgy. Angset, but to all the people of Carasi", said Hon. Rene V. Gaspar, Municipal Mayor.

The construction of the local bridge was funded through the Local Government Support Fund – Assistance to Municipalities (LGSF-AM) 2018 Program of the Department of the Interior and Local Government.

The biggest barangay in the mountainous municipality of Bagulin, La Union was chosen as the showcase barangay for the 1st semester Barangay Assembly Day which is considered as the prime mandatory gathering in the grassroots level. Proclamation No.599, series of 2018 amended previous proclamation and declared every Saturdays and Sundays of March and October of every year as barangay assembly days creating a suited venue to discuss programs, projects and activities of the barangays and to ensure that every sectors' issues and concerns are heard, dissected and properly addressed.

DILG Provincial Director Paulino G. Lalata Jr. graced the event together with Bagulin Mayor Ferdinand D. Tumbaga, Bagulin PNP Chief of Police PInsp. Virgilio Bacani and Provincial PNP Mobile Force head PInsp. Lundon Pang-ag. The Sangguniang Bayan members were also present.

"We encourage all LGUs, especially the barangay councils, to dutifully perform task and responsibilities assigned to you and lead the community in government mandates especially on Disaster Risk-Reduction, solid waste management and war against illegal drugs where the present administration has been seriously inclined to," emphasized by DILG Provincial Director Lalata.

"You may bring issues and concerns in your own sectors as you attend barangay assemblies because barangay officials are not all-knowing," reminded by Mayor Tumbaga.

DILG R1 Launches Enhanced Operation Listo Manual

On March 6, 2019 the Department of the Interior and Local Government Region 1 (DILG R1), being the vice-chair for Disaster Preaparedness, launched the Enhanced Operation Listo Disaster Preparedness Manual.

Some 70 participants, composed of the provincial directors of the Bureau of Fire Protection (BFP) and Philippine National Police (PNP), member agencies of the Risk Reduction Regional Management Council (RDRRMC), provincial officers, DILG R1 personnel and employees, representatives from local government units, and other stakeholders attended the launching of the said manual.

During the opening program, DILG R1 Regional Director James F. Fadrilan emphasized that there can be no substitute for preparedness, citing that the country experiences an average of 20 typhoons every year.

"We expect that with the issuance of the manuals, local chief executives (LCEs) will be properly guided in times of typhoons because sets of disaster preparedness activities are already listed," he added.

The launching of the enhanced Operating Listo Manual was also conducted in the four provinces of the region: Province of Ilocos Sur on March 11, 2019; Ilocos Norte March 12, 2019; Pangasinan on March 13, 2019; and La Union on March 19, 2019. Each provincial launching was attended by the LCEs, local DRRM officers, chief of police, fire marshals, and city/municipal local government operations officers (C/MLGOOs).

During the launching, aside from the presentation of the enhance Listo Manual, the Office of the Civil Defense also presented the different DRRM tools and programs. The PNP and BFP also shared their disaster preparedness strategies while selected LGUs shared their best practices.

The activity also served as a venue for the renewal of the various stakeholder's commitment in a more disaster-resilient region 1. (LGOO IV Karen C. Casulla)
