
The following are the milestones that we, the DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) REGION 1, proudly share with everyone:

- Two of our 4th Income Class Municipalities were awarded with the Seal of Good Housekeeping. Santol, La Union and Alilem, Ilocos Sur were also affirmed eligible for the Performance Challenge Fund (PCF).
 Both were granted with the P1M PCF at the DILG Regional Office;
- Our "hundred percent (100%)" accomplishments:
 - Newly Elected Officials (NEO) Program Component 1 100% organization of transition teams which ensured the smooth transition after the May 14, 2010 Elections;
 - Newly Elected (NEO) Program Component 2 Conduct of the Track 1B, which is Knowing my LGU: thru the State of Local Governance Report, conducted in all the 117 Municipalities of the Region;
 - 3. 129 **2009 State of Local Governance Report (SLGR)** submitted, consolidated and analyzed to complete the Region 1 SLGR;
 - 129 Capacity Development (Cap Dev) Agenda, based on the Systems Competency Assessment for Local Governments (SCALOG), submitted, consolidated, analyzed, and translated to the Region 1 Cap Dev Agenda presented during the Cap Dev Expo 2010;
 - 5. All the **Local Special Bodies (LSBs)** of the 129 local government units of the Region *Local Development Council (LDC), Local Health Board (LHB), Local School Board (LSB), Local Peace and Order Council (LPOC)* were assessed as *Functional* before the turn over of local government leadership;



Three (3) of our Barangays participated in the pilot – testing of the Barangay Governance Performance Management System (BGPMS) of the National Barangay Operations Office (NBOO) DILG Central Office. Two of them – Ortiz, Naguilian, La union and Bonuan Boquig, Dagupan City, Pangasinan – garnered High Performance Rating; while, San Guillermo, San Nicolas, Ilocos Norte garnered an Excellent Rating. Their respective State of Barangay Governance Report (SBGR) is now available at the DILG Regional Office;

Our partnerships:



- 2. Aligned with the Local Resource Institutions (LRIs), particularly the University of Northern Philippines (UNP) and NEDA and Provincial Governments, for the conduct of the Alliance Building, which is Component III of the NEO Program. The Region had already conducted two Alliance Building La Union and Ilocos Sur;
- 3. Joined efforts with the *Provincial League of Planners, NEDA and Housing and Land Use Regulatory Board (HLURB)* for the completion of the Comprehensive Development Plans (CDPs) and Updating of Comprehensive Land Use Plans (CLUPs) of the local government units of the Region. The Province of La Union conducted their workshop on October 26 28, 2010:





- 4. Continued our team up with the Canadian International Development Agency (CIDA) and the One Pangasinan Alliance of LGUs (OPAL) in the implementation of the Local Governance Support Program (LGSP) Local Economic Development (LED). On October 27 29, 2010, the Economic Transformation Team (ETT) for the OPAL was established. Moreover, through the LGSP LED, the Local Governance Regional Resource Center (LGRRC) Team started the production of a local government entrepreneurial guide to eco tourism;
- 5. Established partnership with seven (7) *Civil Society Organizations (CSOs)* through the **Regional Management Coordinating Committee (RMCC).**Moreover, the regional office has monitored a total of 57 CSO *partnership* with the **Provincial and City Governments of the Region**;
- Conduct of the "Biyaheng Pinoy: Capacity Development Expo 2010" where the Biyaheng Pinoy,
 Tapat na Palakad, Bayang Maunlad Project was launched, the Region 1 SLGR and Cap Dev Agenda were presented. The event was participated by partner agencies and LRIs and CSOs. At present, a total of thirteen (13)projects were enrolled by partner agencies and DILG R1 to the Biyaheng Pinoy Project;
- Region 1 LGRRC was promoted to Level 4 –
 Refinement after the Knowledge Management (KM)
 Audit which was conducted on August 12 13, 2010
 at the DILG Regional Office 1. The R1 LGRRC was only
 among the three (3) LGRRCs nationwide which
 reached said level;













- Advocated for the conduct of honest, orderly and peaceful elections *National and Local Election on May 14, 2010 and the Synchronized Barangay and Sangguniang Kabataan (SBSK) Elections on October 25, 2010.* All the COMELEC Resolutions and other election related issuances were disseminated to the concerned local government units. Moreover the **Personal Data Sheets** of all newly elected focal officials were already submitted;
- The operational and newly reconstructed DILG Region website dilgregionone.com. The local government units' data of the region, including the Full Disclosure documents / reports of four (4) municipalities of Ilocos Sur and Pangasinan, is now available.

total of 74 local government units formulated different Codes and passed were this year by the local Sanggunians in response to the identified gaps on governance specifically on Legislation. The Region accomplished the most number on Revenue Codes, since even local governments which were not targeted deemed it a priority. The Region, however, fell short of one Code of General Ordinances to full realize its target;

 All the 34 local government units of the Province of ILOCOS SUR have already accomplished their respective Gender and Development Code and Children's Code, thus the Region's target and accomplishment came from Ilocos Norte, La Union and Pangasinan.



Out of the 123 target **BARANGAY** barangays for **DEVELOPMENT PLAN (BDP)** formulation, only 80 have already prepared their **BARANGAY** respective **ECOLOGICAL PROFILE (BEP)** and out of these 80, only 56 were able to formulate their BDP.

The total target of the Region was on a pilot basis – five (5) barangays for each of the field officers, who underwent the BDP training. Enhancement skills on BDP preparation was a result of the evaluation conducted on BNEO 1.

ADMINISTRATIVE GOVERNANCE: **REVENUE GENERATION**

terms of COMPLIANCE TO THE ANTI -TAPE ACT, the following monitored and reported:

- All the local government units of the Region have already complied with the formulation and publication of their Charters respective Citizens' and establishment of Public Assistance Desk or Complaints Desk;
- Eighty two percent (82) or 106 Provinces, Cities and Municipalities, have complied with the setting up of One – Stop – Shops or Walk - In Service Counters:
- Only 69% or 89 local government units, however, have designated courtesy lanes for pregnant women, Senior Citizens and Persons with Disabilities.

- Fourteen (14) local government units have already re – organized their respective **LOCAL** AIDS COUNCILS, through the efforts of the organized Regional Assistance Team (RAAT);

 - All Provinces were able to comply and post their respective CY 2009
 Statement of Receipts and Expenditures and Items to Bid;
 - The Province of Ilocos Sur failed to post nine (9), out of the 11 required documents / reports;
 - Not one of the four (4) Provinces completed the posting of the 11 required documents / reports. La Union and Pangasinan posted the most number with 10 each;
 - Among the eight (8) Cities, Candon
 City, Ilocos Sur posted the least
 number of the required documents
 / reports, only posting its Items to
 Bid and Bid Results on Civil Works,
 and Goods and Services;

- Complete posting were reported by the Cities of San Carlos, Alaminos and Urdaneta, Pangasinan. The means they used was the posting in conspicuous places;
- The DILG Region official website already accommodated four (4) local government units – Nagbukel, Alilem, and Sugpon, Ilocos Sur, and Bani, Pangasinan – for the posting of their documents.

n its initial year of implementation, the Seal of Good Housekeeping (SGH) Project was implemented in 4th – 5th Class Income Municipalities. Correspondingly, fifty (50)Municipalities in the Region were evaluated and the top regional nominees were:

- 2. Alilem, Ilocos Sur 4th Income Class
- 3. Cervantes, Ilocos Sur 4th Income Class
- 4. Caba, La Union 4th Income Class

Santol, La Union and Alilem, Ilocos Sur were awarded with the Seal of Good Housekeeping and were eligible for the PCF Grant.

Mayors Daisy S. Olivar of Santol, La Union and Mar Ruel P. Sumabat of Alilem, Ilocos Sur receive their respective PhP 1M Performance Challenge Fund. The awarding of the grant was spearheaded by Dir. Manuel V. Biason

NATIONAL PROJECTS FOR REGIONAL IMPLEMENTATION: BARANGAY SAVINGS REPLICATION PROJECT (BSRP)

Monitoring of the status of Bayanihan Centers is still continuing. At the start of year 2010, a total of organized 238 BCs were still operating, however, by the end of the year only 56 of these BCs have been sustained (IN – 28; Ilocos Sur – 13 and Pangasinan 15). The remaining 182 BCs were classified as inactive and some were dissolved already. The inactiveness or dissolution of BCs was attributed to the following factors:

- 1. mismanagement by Account Officers on the established BCs
- 2. inability of BC members to pay their agreed weekly pledges
- 3. failure of the members to pay loans
- 4. mismanaged livelihood programs that lead to bankruptcy and final dissolution of the BCs

These remaining sustained BCs are ready for turn-over to LGUs and other appropriate agencies i.e. cooperatives, multi-financing institutions, and others. However, the Bureau of Local Government Development (BLGD) has not yet issued the guidelines on the turn – over.

CIVIL SERVICE ELIGIBILITY FOR BARANGAY OFFICIALS

A total 105 Civil Service for Barangay Officials Eligibility (CSBOE) applications were endorsed to the Civil Service Commission (CSC) Regional Office I.

SPECIAL LOCAL ROAD FUND (SLRF)

The Regional Office, through the Project Development Management Unit (PDMU), reviewed a total of 21 proposed projects for approval by the Road Board. All the Provinces and Cities submitted their project proposals.

LOCAL GOVERNMENT SCHOLARSHIP PROGRAM (FOREIGN & LOCAL)

There were 14 Regional Memoranda sent to the Provinces disseminating 21 foreign scholarship courses. Three (3) local government applications were reviewed and endorsed for pre – assessment.

ORGANIZATION OF SMALL-MEDIUM ENTERPRISE DEVELOPMENT (SMED) COUNCIL

The Region was only able to muster organization of a total of 35 SMED Councils

NATIONAL PROJECTS FOR REGIONAL IMPLEMENTATION: BUSINESS PERMITS & LICENSING SYSTEM (BPLS) MAINSTREAMING

- Issued a Joint DILG RO1 DTI RO1, Series of 2010 on the Creation of a Coordinating Committee and Technical Working Group (TWGs) to facilitate the roll-out of the Business Permit and Licensing System (BPLS) Reforms to local government units issued on September 1, 2010;
- Each province has its own TWG from DILG and DTI in the coordination and conduct of Orientation Seminar Workshop in the eight (8) priority LGUs of Region I. The Regional DILG and DTI Coordinating team assist and provide the necessary technical assistance to the TWGs:


