

CONTRACT OF SERVICES



KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT OF SERVICE is made and entered into this 12th day of November 2024 in the City of San Fernando, La Union, Philippines, by and between

The **DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT REGIONAL OFFICE 1**, represented herein by **JONATHAN PAUL M. LEUSEN, JR., CESO III - Regional Director**, with office and postal address at Aguila Road, Sevilla Norte, City of San Fernando, La Union 2500, herein referred to as the **First Party**

- and-

The BALAI NORTE HOTELS AND RESORTS CORPORATION represented herein by ERICKA JORGE ADVIENTO with office address at Barangay Panicsican, San Juan, La Union, herein referred to as the Second Party.

WITNESSETH:

WHEREAS, the FIRST PARTY will conduct a one (1) day activity entitled "Conduct of the BNEO M&E Year-End Assessment cum Launching Ceremony of "DAMILI" BNEO Knowledge Product" on November 14, 2024 at Balai Norte Hotels and Resorts Corp., Barangay Panicsican, San Juan, La Union;

WHEREAS, the SECOND PARTY has the capability of providing food for the conduct of the abovementioned activity at reasonable cost;

NOW, THEREFORE, for and inconsideration of the foregoing premises the parties hereto agree on the contents of this Contract to wit:

- 1. THAT the SECOND PARTY agrees and binds itself to the FIRST PARTY to provide food for the participants who will attend the "Conduct of the BNEO M&E Year-End Assessment cum Launching Ceremony of "DAMILI" BNEO Knowledge Product" to be held on November 14, 2024 at Balai Norte Hotels and Resorts Corp., Barangay Panicsican, San Juan, La Union, with the contract package of FIFTY ONE THOUSAND SIX HUNDRED PESOS ONLY (Php 51,600.00) as indicated in the approved activity design subject to the qualification that only the actual cost/billing of the SECOND PARTY shall be paid by the FIRST PARTY as appearing in the Statement of Account;
- THAT this Contract of Services shall be guaranteed for a minimum of 75% of the total number of
 participants. If attendance is above minimum, the SECOND PARTY shall provide food and
 accommodation at the same rate for the additional participants;

- In case of the unforeseen incidental expenses incurred by the FIRST PARTY, the FIRST PARTY shall pay the SECOND PARTY the amount corresponding to it;
- 4. THAT if the total number of participants exceed the foregoing guaranteed minimum number of participants, the FIRST PARTY shall pay the SECOND PARTY additional charges which shall be based on the actual number of participants at the indicated rate per person as indicated in Item #2 of this contract;
- THAT the payment of the amount due and payable under this contract and the conduct of this
 activity is based on the approved and signed program/activity design subject to the usual
 government accounting and auditing rules and regulations;
- 6. THAT the SECOND PARTY guarantees to provide safe and clean food for the said activity to be conducted by the FIRST PARTY, and the latter reserves the right to question any action of, or institute any appropriate action in a proper proceeding against the former for any injury the FIRST PARTY may sustain resulting from any harmful or contaminated food served by the SECOND PARTY;
- 7. THAT in case the SECOND PARTY failed to effect deliveries of what is stipulated herein, without any fault on the part of the FIRST PARTY, or was not due to fortuitous event, the contract will be automatically rescinded without going to court and the FIRST PARTY shall be freed from any liability to the SECOND PARTY;
- 8. **THAT** this contract shall be binding and may be cancelled/terminated at the option of either party upon prior written notice at least five (5) days before the commencement of the activity;
- 9. THAT this Contract shall take effect upon signing of both parties concerned.

WHEREAS, the Bids and Awards Committee (BAC) of the DILG Regional Office 1 adheres to the principles of transparency and competitiveness as mandated under RA 9184 otherwise known as "Government Procurement Reform Act" and its Revised Implementing Rules and Regulations;

WHEREAS, the Procuring Entity intends to Lease a Venue inclusive of Meals and Snacks for the conduct of the BNEO M&E Year-End Assessment cum Launching Ceremony of "DAMILI" BNEO Knowledge Product on November 14, 2024 with an Approved Budget for the Contract (ABC) of Fifty One Thousand Six Hundred Pesos (Php 51,600.00);

WHEREAS, the BAC implemented the procedures prescribed for the Negotiated Procurement - Lease of Real Property and Venue for the aforesaid activity under Section 53.10 of the Revised Implementing Rules and Regulations of Republic Act No. 9184;

WHEREAS, the scheduled BAC Meeting on November 8, 2024, 2:01 PM was postponed because of the suspension of work in all the government offices in the Province of La Union due to Tropical Storm Marce;

WHEREAS, the BAC rescheduled the opening of bids on November 11, 2024, 02:00 PM, with three (3) prospective Service Providers, namely: 1) Balai Norte Hotels and Resort Corp., 2) Awesome Hotel and 3) Villa Elita. However, only Balai Norte Hotels and Resort Corp has submitted its bid proposals with complete eligibility requirements;

WHEREAS, below is the result of the opening and evaluation of bids:

WHEREAS, after a thorough review and evaluation of the BAC, assisted by the Technical Working Group, BALAI NORTE HOTELS AND RESORT CORP was determined to be responsive to the technical requirements having obtained an overall rating of 98.45 % which is above the DILG R1- prescribed passing rate of 85% for the lease of venue;

NOW THEREFORE, WE, the BAC Members, RESOLVE, as it is hereby RESOLVED:

- a) To declare Balai Norte Hotels and Resort Corp as the Single Calculated and Responsive Bidder (SCRB) with a bid amount of Fifty One Thousand Six Hundred Pesos (Php 51,600.00);
- b) To recommend to the HOPE the approval of this recommendation and to **award the Contract for Lease** of Venue to the SCRB.
