

Know all men by these presents:

This **CONTRACT** is entered into by and between **WESTFIELDS RESIDENCES INC. (EUROTEL)** represented by **MS. MA CRISTINA BANDONG, Authorized Representative** with business address at 123 Abanao Exit, Rizal, Baguio City herein referred to as the **FIRST PARTY**.

THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT REGION 1, represented by **DIR. JAMES F. FADRILAN, CESO III, Regional Director**, with office address at Sevilla, City of San Fernando, La Union, herein referred to as the **SECOND PARTY**,

Under the following terms and conditions:

- 1.) That the **FIRST PARTY** will provide meals, snacks and accommodation for the **SECOND PARTY'S** participants for the conduct of **Sustaining DILG R1 Efforts on Peace and Order and Business Friendliness cum PPA Review** scheduled on **March 25-26, 2019**.

- 4.) That extra meals, orders and extension of stay or accommodation shall be billed based on actual head count in excess of the guaranteed number of participants.
- 5.) That any extension of stay shall be made at least one (1) day before occupancy and shall be billed separately.
- 6.) That the **SECOND PARTY** shall pay the contract price **stipulated** above even if the actual number of participants is less than what has been reserved.
- 7.) That, in case the date of activity is postponed or cancelled, the advance payment made accordingly be automatically in favor of the **FIRST PARTY** and could not be refunded.
- 8.) That, in case of incident due to the negligence or fault of the participants, the hotel shall not be held accountable for any Liability whatsoever.


