WITNESSETH:

WHEREAS, The FIRST PARTY will conduct "NEO Orientation Course: Priming Leaders for Effective Local Governance" on August 27-29,2019 at Holiday Inn Baguio City Centre, Baguio City;

WHEREAS, the SECOND PARTY has the capability to provide meals and accommodation for the said activity that shall involve fourteen (14) live-in participants;

PARTY for any injury that the **FIRST PARTY** may sustain from the services of the **SECOND PARTY**;

THAT, in case the SECOND PARTY failed to effect deliveries of what is stipulated herein, without any fault on the part of the FIRST PARTY, or was not due to fortuitous event, the contract will be automatically rescinded without going to court, and the FIRST PARTY shall be freed from any liability to the SECOND PARTY;
- 6. **THAT**, this Contract of Services shall be binding upon the parties but may be amended or cancelled/pre-terminated at the option of either party upon written notice of at least five (5) days before the commencement of the activity.
