

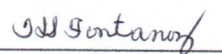

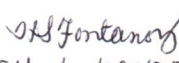

WHEREAS, as mandated under RA 9184 otherwise known as “Government Procurement Reform Act” and its Revised Implementing Rules and Regulations, the Bids and Awards Committee (BAC) of the DILG Regional Office I adheres to the principles of transparency and competitiveness governing this Act;

WHEREAS, the Procuring Entity intends to procure **Printing of IEC Materials Re: Strengthen Information Campaign on Possible Emergence of Peace and Order and Public Health Safety Concerns such as Violent Extremism, CBRN, and Covid Prevention** with an Approved Budget for the Contract (ABC) of **One Hundred Twenty Two Thousand Five Hundred Fifty Pesos (Php 122,250.00)**;

WHEREAS, the procurement was posted at PhilGEPS portal, DILG R1 website and conspicuous places on **May 13-18, 2021**;

WHEREAS, the BAC received eight (8) bids from the following bidders namely: Agoo Printing Press, Innovation Printshoppe, Inc., Gilcor Printing Press, Cover and Pages Corporation, Regencia Printing Press, AG3 Colors Printing Press, Rianella Printing Press, and King Phil Printing Services;

WHEREAS, after the thorough review and evaluation of the Technical Working group, out of the eight prospective suppliers, only four (4) submitted complete eligibility requirements namely: Agoo Printing Press, Innovation Printshoppe, Inc., Gilcor Printing Press and Rianella Printing Press;
