This **CONTRACT OF SERVICE** is made and entered into this 17th day of August, 2022 in the City of San Fernando, La Union, Philippines, by and between

The **DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT REGIONAL OFFICE 1**, represented herein by **RD JULIE J. DAQUIOAG, Ph., D., CESO III, Regional Director**, with office and postal address at Aguila Road, Sevilla Norte, City of San Fernando, La Union 2500, herein referred to as the **First Party**

- and -

The **ARZADON LEISURE AND PROPERTY DEVELOPMENT, INC.** represented herein by **BENJAMIN Y. CRUZ, JR.** with office address at Bonuan Binloc, Dagupan City, Pangasinan, herein referred to as the **Second Party**.

WITNESSETH:

WHEREAS, the **FIRST PARTY** will conduct a **two (2) day** activity entitled “**Workshop on the Encoding of Enrolled Projects under Results-Based Monitoring and Evaluation of LGU Infrastructure Projects (RLIP) – Batch 1**” on **August 18-19, 2022** at **Arzadon Leisure and Property Development, Inc., Bonuan Binloc, Dagupan City, Pangasinan;**

WHEREAS, the **SECOND PARTY** has the capability of providing food and accommodation for the conduct of the above-mentioned activity at reasonable cost;

NOW, THEREFORE, for and inconsideration of the foregoing premises the parties hereto agree on the contents of this Contract to wit:

1. **THAT** the **SECOND PARTY** agrees and binds itself to the **FIRST PARTY** to provide food and accommodation for the participants who will attend the “**Workshop on the Encoding of Enrolled Projects under Results-Based Monitoring and Evaluation of LGU Infrastructure Projects (RLIP) – Batch 2**” to be held on **August 18-19, 2022** at **Arzadon Leisure and Property Development, Inc., Bonuan Binloc, Dagupan City, Pangasinan** with the contract package of **ONE HUNDRED SIXTY THOUSAND EIGHT HUNDRED FIFTY PESOS ONLY (Php 160,850.00)** as indicated in the approved activity design subject to the qualification that only the actual cost/billing of the **SECOND PARTY** shall be paid by the **FIRST PARTY** appearing in the Statement of Account;
2. **THAT** this Contract of Services shall be guaranteed for a minimum of 75% of the total number of participants. If attendance is above minimum, the **SECOND PARTY** shall provide food at the same rate for the additional participants;

3. In case of the unforeseen incidental expenses incurred by the **FIRST PARTY**, the **FIRST PARTY** shall pay the **SECOND PARTY** the amount corresponding to it;
4. **THAT** if the total number of participants exceed the foregoing guaranteed minimum number of participants, the **FIRST PARTY** shall pay the **SECOND PARTY** additional charges which shall be based on the actual number of participants at the indicated rate per person as indicated in Item #2 of this contract;
5. **THAT** the payment of the amount due and payable under this contract and the conduct of this activity is based on the approved and signed program/activity design subject to the usual government accounting and auditing rules and regulations;
6. **THAT** the **SECOND PARTY** guarantees to provide safe and clean food for the said activity to be conducted by the **FIRST PARTY**, and the latter reserves the right to question any action of, or institute any appropriate action in a proper proceeding against the former for any injury the **FIRST PARTY** may sustain resulting from any harmful or contaminated food served by the **SECOND PARTY**;
7. **THAT** in case the **SECOND PARTY** failed to effect deliveries of what is stipulated herein, without any fault on the part of the **FIRST PARTY**, or was not due to fortuitous event, the contract will be automatically rescinded without going to court and the **FIRST PARTY** shall be freed from any liability to the **SECOND PARTY**;
8. **THAT** this contract shall be binding and may be cancelled/terminated at the option of either party upon prior written notice at least five (5) days before the commencement of the activity;
9. **THAT** this Contract shall take effect upon signing of both parties concerned.







**RECOMMENDING THE AWARD OF CONTRACT FOR LEASE OF VENUE TO LEISURE COAST RESORT
FOR THE CONDUCT OF WORKSHOP ON THE ENCODING OF ENROLLED PROJECTS UNDER RESULTS-BASED
MONITORING AND EVALUATION OF LGU INFRASTRUCTURE PROJECTS (RLIP)
FOR BATCH 1 (AUGUST 18-19, 2022), PANGASINAN**

WHEREAS, the Bids and Awards Committee (BAC) of the DILG Regional Office 1 adheres to the principles of transparency and competitiveness as mandated under RA 9184 otherwise known as "Government Procurement Reform Act" and its Revised Implementing Rules and Regulations;

WHEREAS, the Procuring Entity intends to lease a venue inclusive of meals and accommodation for the conduct of Workshop on the Encoding of Enrolled Projects under RLIP for Batch 1 - Pangasinan on August 18-19, 2022 with an Approved Budget for the Contract (ABC) of One Hundred Eighty-Four Thousand Eight Hundred Pesos (P184,800.00);

WHEREAS, the BAC implemented the procedures prescribed for Lease of Venue for said activity under Section 53.10 of the Revised Implementing Rules and Regulations of Republic Act 9184;

WHEREAS, the Canvass Committee floated Requests for Quotation to Three (3) prospective bidders, namely: Dagupan Village Hotel, Star Plaza Hotel and Leisure Coast Resort;

WHEREAS, after thorough review and evaluation by the BAC assisted by the Technical Working Group, only Leisure Coast Resort submitted complete eligibility requirements and quotation;

WHEREAS, the quotation submitted by LEISURE COAST RESORT was determined to be responsive to the technical requirements having obtained an overall rating of 97.8 which is above the DILG R1- prescribed passing rate of 85% for lease of venue;

NOW THEREFORE, WE, the BAC Members, RESOLVE, as it is hereby RESOLVED:

- a) To declare LEISURE COAST RESORT as the Single Calculated and Responsive Bidder (SCRB) with a bid amount of One Hundred Sixty Thousand Eight Hundred Fifty Pesos (Php160,850.00);
- b) To recommend to the HOPE the approval of this recommendation and to **award the contract for lease of venue to the SCRB.**

RESOLVED, further to furnish copy of this Resolution to the **Project Development and Management Unit (PDMU)** and Finance and Administrative Division (FAD) for their appropriate action.


