

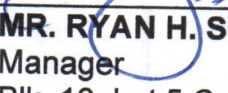

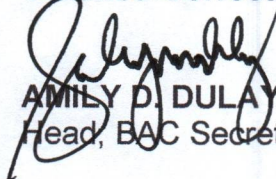
NOW THEREFORE, WE, the BAC Members, **RESOLVE**, as it is hereby **RESOLVED**:

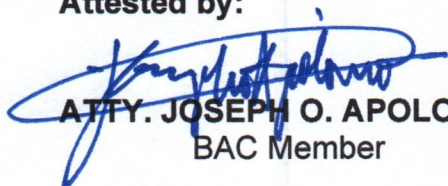

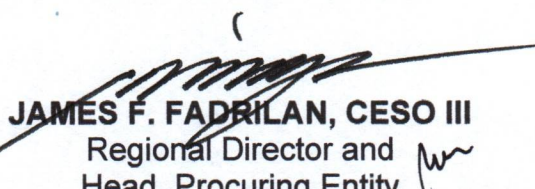
