### CONTRACT OF SERVICES

#### KNOW ALL MEN BY THESE PRESENTS:

This **CONTRACT OF SERVICE** is made and entered into this 1st day of July, 2022 in the City of San Fernando, La Union, Philippines, by and between.

The **DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT REGIONAL OFFICE 1**, represented herein by **RD JULIE J. DAQUIOAG, Ph., D., CESO III, Regional Director**, with office and postal address at Aguila Road, Sevilla Norte, City of San Fernando, La Union 2500, herein referred to as the **First Party**.

- and -

That **AWESOME HOTEL INCORPORATION** represented herein by **REYNANTE V. PATTUNG** with office address at **Eagle St. Ili Norte, San Juan, La Union** herein referred to as the **Second Party**.

#### WITNESSETH:

**WHEREAS**, The **FIRST PARTY** will conduct a **one (1) day** activity entitled “ **Conduct of Regional Planning Conference and Orientation for DILG Program Managers on the Implementation of the 2022 Newly Elected Officials Program** ” on **July 4, 2022** at **Eagle St. Ili Norte, San Juan, La Union** .

**WHEREAS**, the **SECOND PARTY** has the capability of providing food for the conduct of the above-mentioned activity at reasonable cost;

**NOW, THEREFORE**, for and inconsideration of the foregoing premises the parties hereto agree the contents of this Contract to wit:

1. **THAT**, the **SECOND PARTY** agrees and binds itself to the **FIRST PARTY** to provide food for the participants who will attend the “**Conduct of Regional Planning Conference and Orientation for DILG Program Managers on the Implementation of the 2022 Newly Elected Officials Program**” to be held on **July 4, 2022** at **Eagle St. Ili Norte, San Juan, La Union**, with the contract package of **SEVENTY FOUR THOUSAND TWO HUNDRED FIFTY PESOS ONLY (Php 74,250.00)** as indicated in the approved activity design subject to the qualification that only the actual cost/billing of the **SECOND PARTY** shall be paid by the **FIRST PARTY** appearing in the Statement of Account;
2. **THAT** this Contract of Services shall be guaranteed for a minimum of 75% of the total number of participants. If attendance is above minimum, the **SECOND PARTY** shall provide food at the same rate for the additional participants;



3. In case of the unforeseen incidental expenses incurred by the **FIRST PARTY**, the **FIRST PARTY** shall pay the **SECOND PARTY** the amount corresponding to it.


4. THAT, if the total number of participants exceed the foregoing guaranteed minimum number of participants, the **FIRST PARTY** shall pay the **SECOND PARTY** additional charges which shall be based on the actual number of participants at the indicated rate per person as indicated in Item #2 of this contract.
5. **THAT** the payment of the amount due and payable under this contract and the conduct of this activity is based on the approved and signed program/activity design subject to the usual government accounting and auditing rules and regulations;
6. **THAT**, the **SECOND PARTY** guarantees to provide safe and clean food for the said activity to be conducted by the **FIRST PARTY**, and the latter reserves the right to question any action of, or institute any appropriate action in a proper proceeding against the former for any injury the **FIRST PARTY** may sustain resulting from any harmful or contaminated food served by the **SECOND PARTY**;
7. **THAT**, in case the **SECOND PARTY** failed to effect deliveries of what is stipulated herein, without any fault on the part of the **FIRST PARTY**, or was not due to fortuitous event, the contract will be automatically rescinded without going to court and the **FIRST PARTY** shall be freed from any liability to the **SECOND PARTY**;
8. **THAT**, this contract shall be binding and may be cancelled/terminated at the option of either party upon prior written notice at least five (5) days before the commencement of the activity.
9. **THAT** this Contract shall take effect upon signing of both parties concerned.

RECOMMENDING APPROVAL FOR THE NEO REGIONAL PLANNING CONFERENCE**

WHEREAS, the Bids and Awards Committee (BAC) of the DILG Regional Office 1 adheres to the principles of transparency and competitiveness as mandated under RA 9184 otherwise known as "Government Procurement Reform Act" and its Revised Implementing Rules and Regulations;

WHEREAS, the Procuring Entity intends to lease a venue inclusive of meals and snacks for the conduct of Newly-Elected Officials (NEO) Regional Planning Conference and Orientation for DILG Provincial Program Managers on July 4, 2022 for Forty Five (45) participants with an Approved Budget for the Contract (ABC) of Seventy-Six Thousand Five Hundred Pesos (P76,500.00);

WHEREAS, the BAC implemented the procedures prescribed for Lease of Venue for said activity under Section 53.10 of the Revised Implementing Rules and Regulations of Republic Act 9184;

WHEREAS, the Canvass Committee floated Requests for Quotation to Three (3) prospective bidders, namely: Awesome Hotel Incorporation, Villas Buenavista Hotel and Restaurant and EM Royale Hotel and Beach Resort;

WHEREAS, after thorough review and evaluation by the BAC assisted by the Technical Working Group, only Awesome Hotel Incorporation submitted complete eligibility requirements;

WHEREAS, the quotations submitted by AWESOME HOTEL INCORPORATION was determined to be responsive to the technical requirements having obtained an overall rating of 98.05% which is above the DILG R1- prescribed passing rate of 85% for lease of venue;


NOW THEREFORE, WE, the BAC Members, RESOLVE, as it is hereby RESOLVED:

- a) To declare AWESOME HOTEL INCORPORATION as the Single Calculated and Responsive Bidder (SCRB) for the conduct of Newly-Elected Officials (NEO) Regional Planning Conference and Orientation for DILG Provincial Program Managers with a bid amount of Seventy-Four Thousand Two Hundred Fifty Pesos (P74,250.00);
- b) To recommend to the HOPE the approval of this recommendation and to **award the contract for lease of venue to the SCR.B**.




